ANNEX 1 - IFRA CATEGORY PRODUCT TYPES

Below is an extract of information provided by IFRA in relation to types of application present in each IFRA Category. Additional information about IFRA Categories can be found in the Guidance to IFRA Standards, issued by IFRA.

Category	Product Type
1	Lip Products of all types (solid and liquid lipsticks, balms, clear or colored, etc.); Childrens toys
2	Deodorant and antiperspirant products of all types including any product with intended or reasonably foreseeable use on the axillae or labelled as such; Body sprays including body mist
3	Eye products of all types including eye care and moisturizer; Facial make up and foundation; Make-up remover; Nose pore strips; Wipes or refreshing tissues; Body and face paint; Facial masks
4	Hydroalcoholic and nonhydroalcoholic fine fragrance of all types; aftershaves except creams and balms; fragranced bracelets; perfume kit ingredients; scent pads, foil packs and scent strips
5A	Body creams, oils, lotions; Foot care products; Insect repellent intended for skin; All powders and talc excluding baby powders and talc
5B	Facial toner; Facial moisturizers and creams including care products for beard and mustache
5C	Hand cream; Nail care products including cuticle creams and nail lacquer remover; Hand sanitizers
5D	Baby cream/lotion, baby oil, baby powders and talc
6	Toothpaste; Mouthwash including breath sprays; Toothpowder, strips, mouthwash tablets
7A	Hair permanent or other hair chemical treatments (rinse-off), including rinse-off hair dyes
7B	Hair sprays; non-spray styling aids; leave-on hair chemical treatments and dyes; Dry shampoo; Hair deodorizer and hair perfume
8	Intimate wipes; Intimate deodorant spray; Tampons; Baby wipes; Toilet paper (wet)

10B	Animal sprays; Air freshener sprays, manual, including aerosol and pump; Aerosol/spray insecticides
11A	Feminine hygiene conventional pads, liners and interlabial pads; Baby diapers; Incontinence pant/pad; Toilet paper (dry)
11B	Tights with moisturizers; Scented socks/gloves; Facial tissues; Napkins; Pillow spray; Paper towels; Wheat bags; protective facial masks; Solid fertilizers
12	Candles; machine laundry detergents with minimal skin contact; automated air fresheners and fragrancing systems; cat litter; cell phone cases; non-skin-contact deodorizers; dryer sheets; fuels; non-aerosol insecticides; incense; machine dishwasher products; olfactive board games; paints; plastic articles excluding toys; scratch and sniff; scent packs; scent delivery systems; shoe polishes; rim blocks; toilet gel; scent beads
